Scientific Assistant –A on contract: -

The candidates will be shortlisted for document verification on the basis of marks obtained in educational qualification [Diploma] and one year post qualification relevant experience in order of merit. The candidate will be selected subject to successful verification of document verification.

7.RESERVATIONS AND RELAXATIONS:

Relaxation of Marks: 1st Class is relaxed to 2nd Class with 50% marks in aggregate for SC candidates.

Age Relaxation: Upper Age limit as on 31.01.2021 should not be more than 30 years for General & EWS candidates. The upper age limit will be relaxed for SC, ST candidates by 5 years and for OBC candidates by 3 years. For candidates belonging to PWD category having minimum 40% disability or more, will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

The upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01.01.1980 to 31.12.1989.
