ELIGIBILITY CRITERIA

a) Court Assistant

- Must have passed Intermediate examination conducted by Telangana State Board of Intermediate Education or its equivalent.
- Any retired person who held any post i.e. Junior Assistant, Typist, Copyist, Examiner in the Judicial Department is eligible.

b) Court Attendant

- 1) Must have passed 7th Class examination for the post of Court Attendant
- Any retired person who held the post of Office Subordinate (Attender), Process Server or in any post in the Last Grade Service in the Judicial Department is eligible.

II) AGE:

- As on 01.07.2021 the candidates must not have completed (34) years and must have completed (18) years. The relaxation of maximum age limit is 5 years in respect of SC/ST and BC Candidates and 10 years in respect of Physically handicapped and Ex-Servicemen.
- Any retired employee who crossed the age limit of 65 years shall not be eligible for the appointment of Court Assistant and Court Attendant.

III) DOCUMENTS TO BE ENCLOSED TO THE APPLICATION:

- Attested copy of certificates of Academic qualification.
- Attested copy of certificate evidencing date of birth.
- One recent passport size photograph of the applicant is to affixed at the top of the application in the place specified.
